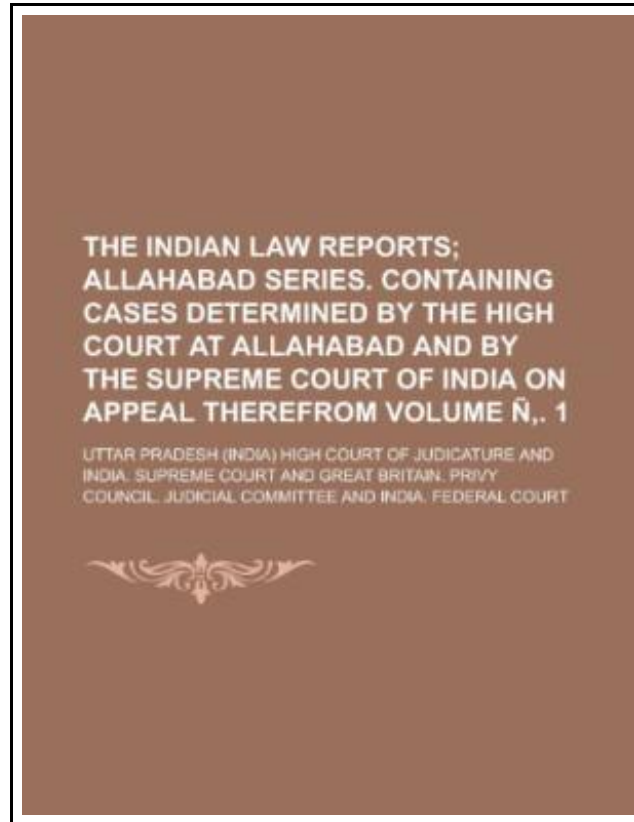

Instead of doing so the Court entertained the question of the accounts and came to the conclusion that in respect of the profits of the business it was reasonable to allow a certain sum to the plaintiffs. The sum is not arrived at upon any accounts furnished by the defendants or appearing in any account books. It is mere guess work. It has been pointed out by their Lordships of the Privy Council in the case of Hurrnath Roy Bahadur v. Krishna Coomar Bukthi (1) that in a suit for an account the Court, following the general rule, ought not to make a final decree at the hearing, but should order an account to be taken of the agents dealings with the plaintiffs money. That is the course which the Court below ought to have followed. On finding that there was no partnership between the defendants and the plaintiff, the Court ought to have directed the usual agency accounts to be taken. The same question came before this Court in the case of Bam Das v. Bhagwat Das(2). There the Court held that, the fact of agency being established, it is the duty of the Court to fix a date for the furnishing of accounts, and that, once the plaintiff has shown that the defendant is an accounting party, then...
